COMMUNITY POLICY

Community can be defined as a group of people who live in the same areas or as the actual shared area of a group of people.

This Community Policy was designed to provide for the general wellbeing of each Resident, by determining guideline of general conduct. Appropriate individual conduct is essential in maintaining the harmonious existence in the Public Housing Communities. Periodically, these polices may change, at the sold discretion of the Management and in accordance with the Occupancy Policies. Any violation of these Policies will be considered a breach of lease. Each of these policies applies to all Resident. Residents are responsible for their households and any guest knowing and following the policies.

NEIGHBOR DISAGREEMENTS

At no time will the Abilene Housing Authority take sides in the disputes or arguments between Residents. The Management will provide mediation for problems. If conflict continues after intervention of the Management, the termination or non-renewal of the leases of the involved parties may occur.

COMMUNITY APPEARANCE

Building Exteriors - porches, yards and all external areas must be kept safe, sanitary, and uncluttered. These areas are not storage areas. Nothing will be attached, suspended, or displayed from buildings, fences, and trees. Any violation of this policy will lead to confiscation of resident property and possible eviction.

COMMUNITY APPRERANCE

Decorating and Housekeeping -_no_ modification of a permanent nature (interior or exterior) is permitted without prior written authorization of the Management. All Residents are responsible for the cleanliness of their apartments and the surrounding areas. All Residents are also responsible for keeping their apartments, including light fixtures and appliances in good repair.

A. Pictures and other articles may be attached to the interior walls if they can be removed without damage. The largest allowed nail size if 4. Larger sized nails and stick on hangers are strictly prohibited.

B. Riviera Residents are not furnished with mini-blinds. All liners, drapes, curtains, shades, and window coverings must have a white backing. Aluminum foil and solar film is not permitted in any window.

MAINTENANCE

Maintenance - If maintenance is required the Resident will advise the Management of the situation, so that a work order can be issued. When repairs are needed, the Resident should notify the office. Non-emergency maintenance problems will be reported Monday - Friday, 8:00 a.m. to 5:00 p.m. Outside the regularly scheduled office hours, an emergency number (676-6032) is available. This number is for emergencies (201-2600) only. The A.H.A. will be responsible for repair of the unit within reasonable time. If the damage is the due to "normal wear and tear" there will be no charge for this service. However, if the Resident of the Resident's household or guests causes the damage, the reasonable cost of the repairs shall be charged to Resident, in accordance with the listed schedule of charges.

MAINTENANCE

The A.H.A. resolves work orders according to priority. Emergencies will be taken care of first. Emergency jobs include conditions that pose an immediate threat to life, health, safety, property, or are related to fire safety. Examples of emergency conditions include, but are not limited to, and unhealthy or undrinkable water supply, gas leak, broken/blocked sewer line, failed heating system, hazardous electrical system, damaged locks and doors, ceiling leaks, broken windows except storm windows, clogged commode or tub (if only on in unit), and clogged kitchen sink. Non-emergencies will be repaired as quickly as possible.

Non-emergency conditions are those that do not pose an immediate threat to life, health, safety, property, or are not related to fire safety.

NOISE

The hours of 10:00 p.m. to 6:00 a.m. are designed "Quiet Hours". The A.H. requires that TV's, instruments, stereos, and voices are kept to a minimum between these hours. Social gatherings of residents are permitted except in the parking area. It is the Resident's responsibility to ensure that these gatherings are not inappropriate or objectionable to other residents. The Resident also accepts full responsibility for any guest on Public Housing property.

The Texas Chapter of the National Association of Housing and Redevelopment Officials (TXNAHRO) is a professional membership organization consisting of agencies and individuals who administer housing and community development in the state of Texas. NAHRO is the leading housing and community development advocate for the provision of adequate and affordable housing and strong, viable communities for all Americans: particularly those with low and moderate incomes.

TXNAHRO provides scholarships each year to deserving high school seniors, graduating in the Spring following this application deadline, and who are currently living with their families as Public Housing or Section 8 program residents.

Available scholarships are one (1), \$2,500 Jim Hargrove Scholarship, and eight (8)

\$1,000 scholarships. To be eligible, you must:

- 1. Be a resident of public housing or a participant in the Section 8 program in which you are living.
- 2. Be a graduating high school senior. (You cannot have graduated in the previous year or be in college already for this scholarship. It is intended to help high school seniors get started immediately in college).
 - 3. Demonstrate exceptional school attendance.
 - 4. Demonstrate high academic achievement.
 - 5. Demonstrate leadership and/or high level of motivation.
- 6. Be a resident of a Housing Authority/ or Community Development (CD) agency that is a member of TXNAHRO.

Application Deadline: February 16, 2024

Applicants are required to submit the following items:

Housing Agency Certification signed by the Executive Director of the housing agency in which you reside (click here to download form)

Transcript or certified copy of grades with grade point average and scale used - whether 4 pt. scale, 5 pt scale, etc., class ranWsize, proficiency test scores (TAKS, etc., whatever standardized testing system is used and ACT and/or SAT scores, if taken). It is very important to include all the above information so that all scholarship applicants can be evaluated on the same criteria.

*TWO letters of recommendation; one from a community leader and one from a high school instructor.

One (1) recent photo (if a professional photo is not available, even a cell-phone selfie will be accepted, if a better-quality portrait is unavailable). This is very important for the awards ceremony!

NEW Please submit a 3 minute or less video of yourself describing your short and long-term goals in life, why you are pursuing your particular college degree or vocational training program and an achievement or an event in your life that has been especially significant.


